##### **Preamble – Recital (1)**

- 1** In lieu of amendment 1 of the Paper of Amendments deposited on 2 March 2021, the following amendment should be made –

Page 1, line 1, delete “the London Cemetery Company Act 1836” and insert “an Act of the sixth and seventh years of the reign of His Majesty King William the Fourth, entitled “An Act for establishing Cemeteries for the Interment of the Dead, Northward, Southward, and Eastward of the Metropolis, by a Company to be called “The London Cemetery Company”” (“the 1836 Act”)”

##### **Preamble – Recital (2)**

- 2** In lieu of amendment 2 of the Paper of Amendments deposited on 2 March 2021, the following amendment should be made –

Page 1, line 7, delete “the London Cemetery Company Act 1843” and insert “an Act of the sixth year of the reign of Her Majesty Queen Victoria, entitled “An Act for amending the Act establishing “The London Cemetery Company”””

## **Clause 2 – Interpretation**

- 3 In lieu of amendment 4 of the Paper of Amendments deposited on 2 March 2021, the following amendment should be made –

Page 2, line 17 at end insert ““the 1836 Act” means the Act of the sixth and seventh years of the reign of His Majesty King William the Fourth, entitled “An Act for establishing Cemeteries for the Interment of the Dead, Northward, Southward, and Eastward of the Metropolis, by a Company to be called “The London Cemetery Company”””;

## **Clause 10 – Repeals and Savings**

- 4 In lieu of amendment 12 of the Paper of Amendments deposited on 2 March 2021, the following amendment should be made –

Page 8, line 35, delete “London Cemetery Company Act 1843 (1843 c. xxxvi)” and insert “the Act of the sixth year of the reign of Her Majesty Queen Victoria, entitled “An Act for amending the Act establishing “The London Cemetery Company”””

- 5 Page 8, line 36, before “London” insert “the”

- 6 In lieu of amendment 39 of the Paper of Amendments deposited on 24 February 2021, the following amendment should be made –

Page 8, line 36, at end insert –

“(1A) Sections 118 and 119 of the 1836 Act are repealed so far as they relate to the cemetery on the date on which byelaws made under section [9] come into operation.”
